Executive Summary

• The Consolidated Annual Performance and Evaluation Report (CAPER) meets the performance reporting requirements of the U.S. Department of Housing and Urban Development (HUD) as set forth in the Consolidated Plan Regulations at 24 CFR 91.520. This report describes the Community Development Block Grant (CDBG)- funded activities undertaken by the city of Berwyn during Program Year 2024, beginning October 1, 2024, and ending September 30, 2025.

These grants fund community development efforts to improve housing, economic, and social conditions, as well as opportunities for low-income and moderate-income residents of the city.

The city funded and administered projects to address the four main goals of the Consolidated Plan. The city also promoted its goals and strategies through administrative actions, including supporting nonprofits, planning and coordinating local resources, and collaborating with other organizations and governmental agencies such as Cook County / the Cook County Consortium. The city did not hinder the implementation of any part of the Action Plan or Consolidated Plan through action or willful inaction.

A draft of this report is available for public review and comment period beginning November 25, 2025. The city solicited written comments and will hold a public hearing on the CAPER at 10:00 a.m. on December 5, 2025 at 6700 W 26th Street, Berwyn, Illinois. The complete document is available for review at Berwyn city Hall, the Berwyn Public Library, the Community Development Department, and the city's website.

These grants fund community development efforts to improve housing, economic, and social conditions in the city, and provide opportunities for its low-income and moderate-income residents.

This report summarizes the accomplishments of program year 2024 (PY24), the fifth and final year of the city's 2020-2024 Consolidated Plan.

The current consolidated plan placed a high priority on improving infrastructure and public facilities across Berwyn's low- and moderate-income neighborhoods. The PY 2024 Annual Action Plan followed the plan, investing heavily in public improvements and facilities. The city completed sewer, street, and sidewalk improvements in low- and moderate-income areas during the 2024 program year. This year, the city also directed resources to the southwest area of Berwyn—an area newly qualifying as low- and moderate-income—to address long-standing infrastructure needs.

Public service and homelessness activities funded during the program year assisted eligible residents by providing transportation services for seniors and people with disabilities through the Senior Bus Program, dental services for income-qualified youth through The Children's Clinic, and domestic violence prevention and homelessness prevention services administered by BEDS Plus Care, Inc.

During Program Year 2024, the city's Single Family Rehabilitation Program completed three housing rehabilitation projects and began two more for completion in early PY 2025. Five more homes are expected to be completed by the close of the PY 2025 grant year.

Assess how the jurisdiction's use of funds, particularly CDBG, addresses the priorities and specific objectives identified in the plan, giving special attention to the highest priority activities identified.

As summarized below. Berwyn targeted its CDBG and CDBG-CV funds toward achieving its highest-priority Consolidated Plan and Action Plan goals in 2024.

Affordable Housing Priorities

To address the city's aging housing stock, the Consolidated Plan placed a high priority on supporting Berwyn homeowners in maintaining their homes and addressing repairs that posed health and safety hazards. The plan supported the Single Family Rehabilitation Loan Program (SFR Loans) to assist low- to moderate-income residents (under 80% AMI) in making code-compliant home repairs. This effort aims to maintain the number of units available to LMI residents and the number of LMI residents living in owner-occupied housing. SFR Loans are no-interest, no-payment loans that are repaid when the owner sells or refinances the property.

The Community Development Department continues to work with homeowners to identify viable projects. In PY 2024, 107 homeowners contacted CDBG for SFR information. Staff reviewed the application process with 32 homeowners seeking financial assistance. Eleven online and five in-person applications were provided to residents interested in the program. Sixteen homeowners submitted completed applications and supporting documents for approval. Seven applications were rejected based on income or failure to provide additional financial documents. Nine applications were approved. Three projects were completed, and two additional projects were initiated in PY 2024 and will be completed by December 2025. The SFR Coordinator contacted homeowners who requested applications offering further assistance.

While the city continues to conduct outreach and receives ongoing interest in the Housing Rehabilitation Program, it has faced challenges in qualifying applicants due to income-eligibility requirements. As part of the 2025–2029 Consolidated Plan, the city will introduce forgivable grants specifically targeted for ADA improvements to expand access to eligible households.

Homeless priorities

The Consolidated Plan identified homeless persons who were unsheltered and living in places not fit for human habitation in Berwyn. During the program year, homeless provider subrecipients funded their services through other sources such as ESG and other CARES Act grants. Therefore, the city funded other programs while continuing to coordinate with homeless service providers and the Alliance to End Homelessness during PY

2024. The city will continue this coordination and directly fund emergency shelter for persons experiencing homelessness when appropriate.

Accomplishments for each of these programs are described in greater detail in the CDBG Activity Summary Report (PR03) report in the appendix. In addition to directly funding programs, the city, which does not receive Emergency Solutions Grant funding, also addresses homeless priorities through its engagement with the Alliance to End Homelessness in Suburban Cook County. The Alliance coordinates the assessment and outreach to homeless persons throughout several surrounding jurisdictions. See CR-25 -Homeless and Other Special Needs below for additional information.

Public Services

During the consolidated planning process, survey respondents and forum participants frequently highlighted the need for health and support services for vulnerable populations. Residents were particularly concerned that the existing services did not meet the needs of the senior and youth population. There was also a strong demand for services and facilities to meet the needs of youth, seniors, and working parents in need of childcare. During PY 2024, the city supported high priority community (public) service activities identified in the Consolidated Plan, including:

- The Berwyn Senior Bus Program provided bus transportation for 316 Berwyn seniors, including 138 seniors with disabilities.
- The Children's Dental Clinic Program provided 310 Berwyn children with in-clinic preventive and restorative dental care.
- BEDS Plus provided Homelessness Prevention rental assistance to 58 Berwyn residents, and provided Homeless Supportive Services to
 96 Berwyn Residents

Public Facilities

Public Facilities and Public Improvements emerged as among the highest rated priorities needs in both the community forums and the individual survey responses. In fact, improving a broad range of public infrastructure was the greatest priority for PY 2024. The city targeted most funds for enhancing the viability of low- and moderate-income neighborhoods through street, sidewalk, and sewerage programs. The city continues to advance its long-term initiative to eliminate architectural barriers in public and community facilities, consistent with its commitment to improving ADA accessibility.

- Sidewalks: The city replaced 30,066 sq. ft. of CDBG sidewalks, 276.5 ft. of concrete curb and gutter, and 110 sq. ft. of ADA-compliant detectable warnings, including the restoration of all disturbed areas.
- Sewer: The 2024 city Sewer project included adjusting 15 catch basins, 4,864.4 FT of combined sewer televising, replacing 35 frames and

- lids, and replacing 100 FT of clay-combined sewer.
- Streets: The 2024 city Street Project replaced approximately 4,325 LF of deteriorated streets, 280 LF of sidewalks, 50 LF of detectable warnings for ADA compliance, and 1,647 LF of pavement markings.

Community Development Block Grant CARES-ACT (CDBG-CV)

Berwyn received \$1,107,768 in supplemental CDBG funding (CDBG-CV) to respond to the COVID-19 public health crisis in installments from 2020 to 2022. The city amended the PY 2019 Action Plan, which was part of the 2015-2019 Consolidated Plan, to include new activities to prevent, prepare for, and respond to the impacts of the coronavirus. Because the CDBG-CV funds are associated with a prior consolidated plan, Table 1 above did not capture the results.

As described below in section CR-45, Berwyn reprogrammed CDBG-CV funds to address evolving needs, alternative funding, and recipient organizations' administrative capacity to carry out programs. The city added new projects to improve the city of Berwyn Recreation Department's public facilities to protect and mitigate the impact of future health emergencies, and to support Mental Health service Counselors at the Police Department. The following table summarizes the uses and status of CDBG-CV funds.

Berwyn completed both the Recreation Department bathroom project and the Recreation Department HVAC replacement in PY 2023. MOU agreements between the city of Berwyn, the Police and Recreation Departments were completed and signed on May 4, 2022. In PY2024, the Berwyn Police Counselors Program provided critical support to 40 residents experiencing domestic battery. Counselors engaged affected individuals through multiple outreach phone calls, offering crisis intervention, safety planning, and ongoing emotional support. Although this remains a highly valuable program for the community, the Police Department has elected to continue operating it without CDBG funding due to the administrative and documentation requirements associated with the program. The service continues to be available to Berwyn residents and remains an essential component of the city's overall response to domestic violence.

Narrative

The city expended \$1,658,397.68 in CDBG Funds during PY 2024, including reallocated prior-year funds and program income. During the program year, Berwyn receipted and expended \$79,600.65 in Program Income. About 84 percent of non-administrative expenditures were invested in public infrastructure, with the remaining expended on public services and affordable housing rehabilitation. In addition, the city expended \$12,292.72 of CDBG-CV funds in PY 2024.

The city met or exceeded all CDBG standards during the program year:

- Nearly 100% of funds were expended on activities that benefited low and moderate-income residents
- The city expended or obligated 18.64% during PY 2024 year grant for planning and administration, meeting the 20% statutory cap for these activities. A second planning and administration test looks at the actual CDBG grant funds used (excluding program income). Berwyn has remained below 20% of grant funds excluded in all years since the test's inception. Total expenditures and unliquidated obligations for public service activities (adjusted for expenditures against previous unliquidated obligations) was 9.69% of the annual grant, under the 15% statutory cap on public service activities.
- The city met its timeliness test obligation, with a 1.17 ratio, below the 1.5 CDBG standard, on August 2, 2025. The city also continued to expend funds on large infrastructure projects through the remaining program year.

Narrative

The city's CDBG allocation is devoted to serving Berwyn's low- to moderate-income population. CDBG Public Improvements and Facilities activities are in and targeted exclusively to neighborhoods and Census Tracts where most residents are low- to moderate-income. Low- and moderate-income census tracts are dispersed throughout Berwyn's area of less than four square miles.

Leveraging

Fund leveraging was encouraged among the city's CDBG partners. The city especially benefited from additional resources that local and regional nonprofit organizations brought to provide a wide range of services to residents with low or moderate incomes and special needs. Subrecipient-leveraged funding sources included organizational fundraising, private donations, Cook County and State of Illinois funds, other Federal resources, and in-kind contributions. For PY 2024, subrecipient organizations awarded CDBG funds anticipated leveraging approximately \$1.1 million. No publicly owned land within the city of Berwyn is utilized for CDBG.

Discuss the difference between goals and outcomes and problems encountered in meeting these goals.

The city continues to promote its Single-Family Rehabilitation Program actively. During Program Year 2024, the program completed three rehabilitation projects and initiated two additional projects, anticipated to be completed by December 2025. Looking ahead, the city projects completing approximately five additional rehabilitation projects within the PY2025 grant year.

While the city has made progress in identifying and qualifying households that meet the program's income eligibility criteria, new challenges have emerged—specifically, difficulties in securing contractor participation and receiving sufficient bids for these projects.

Discuss how these outcomes will impact future annual action plans.

The city remains committed to the Single-Family Rehabilitation program as both a means to help lowand moderate-income residents remain in safe and suitable housing and to maintain the viability of its many residential neighborhoods. The city continues to aggressively expand outreach to boost program participation and has taken a more active role in working with smaller contractors. For instance, the city continues to identify new ways to inform residents about the single-family rehabilitation program, such as enclosing program brochures in water bills.

Narrative Information

The city's Community Development Block Grant (CDBG) allocation is dedicated to serving Berwyn's low-to moderate-income residents. As a small Entitlement grantee with limited resources, the city strategically partners with regional organizations to address the most severe housing needs within the community. The city of Berwyn is an active member of the Cook County Consortium and continues to support efforts that promote affordable housing development. Community needs are further addressed through public service activities implemented by various subrecipients and in coordination with the local Continuum of Care (CoC).

Through the Single-Family Rehabilitation Program and in partnership with the North West Housing Partnership, CDBG funds are also made available to assist homeowners with disabilities in modifying their homes to improve accessibility, including the installation of ramps, lifts, and other adaptive features.

Reaching out to homeless persons (especially unsheltered persons) and assessing their individual needs

As a small CDBG-only Entitlement community that does not receive ESG funding, the city provides referrals and supports the Alliance to End Homelessness in Suburban Cook County, which coordinates assessments and outreach for homeless persons across several surrounding jurisdictions. The city continued leveraging federal and state resources to assist provider agencies through services.

Addressing the emergency shelter and transitional housing needs of homeless persons

Throughout Cook County, emergency, transitional, and safe-haven facilities provide shelter for veterans, households, and individuals. Although the city of Berwyn does not have any homeless shelters within its municipal boundaries, residents have access to nearby resources through BEDS Plus, Inc., located at 9601 Ogden Avenue in La Grange, and Housing Forward, located at 1851 South 9th Avenue in Maywood. BEDS Plus provides emergency shelter, homelessness prevention, street outreach, and supportive housing services to individuals and families experiencing or at risk of homelessness throughout West and South Cook County. Housing Forward offers a comprehensive continuum of services—including crisis intervention, emergency shelter, rapid re-housing, and supportive housing programs—designed to help individuals achieve stability and long-term self-sufficiency.

Helping low-income individuals and families avoid becoming homeless, especially extremely low-income individuals and families and those who are: likely to become homeless after being discharged from publicly funded institutions and systems of care (such as health care facilities, mental health facilities, foster care and other youth facilities, and corrections programs and institutions); and, receiving assistance from public or private agencies that address housing, health, social services, employment, education, or youth needs

Due to limited capacity, the city's approach to helping residents avoid homelessness and transition to permanent or independent housing is primarily referral-based. The city refers residents to the Alliance to End Homelessness in Suburban Cook County and the Cook County Housing Authority.

Helping homeless persons (especially chronically homeless individuals and families, families with children, veterans and their families, and unaccompanied youth) make the transition to permanent housing and independent living, including shortening the period of time that individuals and families experience homelessness, facilitating access for homeless individuals and families to affordable housing units, and preventing individuals and families who were

recently homeless from becoming homeless again

The city works closely with the Alliance to End Homelessness in Suburban Cook County, Housing Forward, and BEDS Plus to support several nonprofit organizations and programs. These partners work with persons experiencing homelessness. They assist elderly persons with severe mental illness and disabilities, substance abuse problems, or HIV/AIDS to help prevent homelessness.

This support includes: helping homeless persons (especially chronically homeless individuals and families, families with children, veterans and their families, and unaccompanied youth) make the transition to permanent housing and independent living; preventing individuals and families who were recently homeless from becoming homeless again, and; helping those who are likely to become homeless after being discharged from publicly funded institutions and systems of care.

BEDS Plus provided the following data:

In PY2024, BEDS Plus provided 154 Berwyn residents with homeless prevention and supportive services, including 22 who relocated from nearby communities. Of these 154 residents:

- 58 received homeless prevention rental assistance
- 96 residents received other homelessness supportive services, including:
 - o 36 received street outreach supportive services
 - 5 received homelessness diversion
 - 20 received triage emergency shelter
 - 1 received medical respite
 - 3 received motel-based interim housing
 - 1 received bridge housing
 - 22 received supportive housing
 - 3 of these residents enrolled in the Workforce Development Pilot Program
 - 8 received DCFS housing navigation

In addition to supporting individuals by preventing evictions and leasing a growing number of housing units for transitional housing programs, housing services help stabilize the Berwyn real estate market.

Actions taken to address the needs of public housing

Berwyn does not have a public housing authority or administer a Section 8 rental assistance program. However, the Housing Authority of Cook County (HAAC) provides this rental assistance to Berwyn residents. It manages public housing and Housing Choice Vouchers low-rent units for County residents, located throughout the county. The vast majority of assisted households were extremely low-income, with the rest either low- or moderate-income. Assisted households included elderly and disabled (heads of household), as well as large households.

There are no Low-Income Housing Tax Credit (LIHTC) units in Berwyn. The city provides referral information for public housing resources and the Housing Choice Voucher program. There are no city requirements that would preclude HCV holders from renting from private landlords in the community.

Actions taken to encourage public housing residents to become more involved in management and participate in homeownership

As noted, Berwyn continues to support housing development, homeownership, and fair housing in our community. The city does not have land available for new development; however, preserving units as a priority benefits all local residents, including those who may be clients of the HAAC. The city is also a willing partner of the HAAC, as needed, to support its residents and make referrals to local housing counseling agencies as requested.

As noted in the city's Consolidated Plan and this CAPER, Berwyn supports public policies, funding, and actions that expand the creation of affordable housing, especially for lower-income households. city staff participates in regional discussions on mixed-income and inclusionary zoning, as well as other potential policies to promote affordable housing. Having few vacant parcels, the city's existing housing stock remains the largest reservoir of opportunities to provide this housing.

Berwyn supports public policies, funding, and actions that expand the creation of affordable housing, especially for lower income households. City staff participates in regional discussions on mixed-income and inclusionary zoning, as well as other potential policies to promote affordable housing.

The City will continue to collaborate with Cook County and neighboring municipalities to expand housing opportunities for all populations and to advance regional fair housing goals. The City will also maintain ongoing coordination with the Cook County Consortia to meet evolving AFH requirements and to support efforts to affirmatively further fair housing across the region.

The city's adopted comprehensive plan provides a guide and framework for facilitating new development and preserving a good quality of life for all in Berwyn. The city implemented a new zoning ordinance that will reinforce these goals and support a sustainable future.

The provisions of this Zoning Code are adopted pursuant to the city's home rule authority under Article VII of the Constitution of the State of Illinois (1970) and the authority granted to the city by the Illinois Municipal Code for the following purposes:

- (A) Protect and promote the health, safety, comfort, convenience, and general welfare of the public.
- (B) Ensure adequate light, air, open space, privacy, and access to property.
- (C) Implement the goals and objectives of the city's Comprehensive Plan and the other land use policies of the city.
 - (D) Maintain and promote orderly land use patterns and development.
 - (E) Facilitate the provision of adequate public services and infrastructure.
- (F) Protect the city's quality of life and the character of its neighborhoods by ensuring that development is compatible and cohesive.

- (G) Protect and enhance the taxable value of land, buildings, and structures.
- (H) Promote development that sustainably manages environmentally sensitive issues.
- (I) Define the responsibilities of the city's administrative bodies and establish procedures for the effective use of the provisions of this Code.

Actions taken to address obstacles to meeting underserved needs. 91.220(k); 91.320(j)

Underserved needs are primarily a function of the city's aging housing stock and infrastructure, and dependent populations are most likely to bear the burden of these needs. Strategies to address concerns, such as poverty, lead-based paint hazards, affordable housing, homelessness, and the physical environment, depend on limited federal funding. However, the City strives to meet these needs by working cooperatively with the County, the State, and nearby jurisdictions.

Realizing that CDBG funds are severely limited, the city's program has made every effort to encourage owners to maintain their properties. It has worked with the federal, state, and county governments to apply for and implement an array of programs, ranging from foreclosures to homelessness, and provide affordable housing opportunities to all those in need.

Vulnerable populations in Berwyn include the elderly, persons with disabilities, and those seeking work who cannot find employment. The City relied on its network of public and nonprofit service agencies, along with its ties to the private sector and economic development agencies, to provide an array of supportive services and limited financing. CDBG funds will also support ADA improvements at public facilities, benefiting seniors and people with disabilities.

Actions taken to reduce lead-based paint hazards. 91.220(k); 91.320(j)

All of the city's federally funded housing programs are designed to comply with the lead paint requirements of 24 CFR Part 35. Most of the CDBG-funded housing activities require lead-safe work practices. The City maintained its lead inspection and abatement requirements for its housing rehabilitation programs. It offered lead paint hazard remediation through its Single Family Rehabilitation Program for very-low, low-, and moderate-income homeowners.

All contractors selected under the city's Single Family Rehab program must be lead certified. Other organizations joined in warning about the dangers of lead poisoning and provided homeowners with information on how to renovate and preserve Berwyn's historic homes safely.

Participants in the city's programs are advised of the potential dangers posed by lead-based paint in their homes and sign a form verifying that they understand the hazard. The advisory sheet informs residents of the potential for lead-based paint hazards in their homes. It provides brief lead-based paint awareness information with instructions on obtaining the city's brochure for further details.

The City of Berwyn assists and encourages residents to replace their lead water services to promote better health through clean water. The City has extended the Lead Service Replacement program by waiving the tap connection fee for owner-occupied residential homes with three units or less. In addition, the City will restore the street after completing inspections and ensuring it is properly backfilled.

Berwyn continues to work with the Cook County Department of Public Health, the Illinois Department of Public Health, and other agencies to increase awareness of lead paint hazards. Berwyn Public Health District worked with McNeal and Loyola Hospitals to test pre-school children for lead poisoning. In PY 2023, 20 Berwyn children were referred to CCDPH. Berwyn has the second-highest number of children referred for lead exposure of all communities in CCDPH's suburban jurisdiction (over 120 communities). Since 2019, close to 100 children have been identified with elevated blood levels. During the PY 2023 program year, one housing unit was remediated. Three additional units are in the process, but not yet complete. CCDPH grant dollars are still available to help residents up to 120% Area Median Income with lead hazard repairs.

Once again, the City and Cook County coordinated efforts to prevent lead exposure to young children living in Berwyn as part of October's Poison Prevention Month activities. Parents with children under four were encouraged to contact the Berwyn Health Department to schedule a lead poison screening. Parents were notified that federal funds were available to test and remove lead and were directed to the city's website for more information.

The City continues to create ordinances by using the Lead Poisoning Prevention Act to increase compliance with activities that identify exposed children or prevent exposure. The City will provide support and incentives for housing improvements to protect children from lead exposure from deteriorated lead-based paint and lead pipes. The City is exploring implementing a prospective rental inspection (PRI) program for multi-unit housing to identify lead hazards and require their correction. The Building Department will identify activities to ensure lead-safe work practices are developed and implemented by connecting contractors to lead-safe work practice training and explore the feasibility and value of implementing a Berwyn healthy homes or lead-safe ordinance.

Actions taken to reduce the number of poverty-level families. 91.220(k); 91.320(j)

During the program year, the City continued to coordinate with Cook County and partner jurisdictions to address affordable housing, homelessness, and fair housing needs. Cook County advanced several initiatives that support Berwyn's Consolidated Plan goals, including new down-payment assistance for eligible homebuyers, a modular housing pilot to expand affordable homeownership opportunities, and continued implementation of the Affordable Housing Special Assessment Program to preserve affordable rental units countywide.

The County also strengthened its homelessness response by expanding fixed-site emergency shelter capacity, non-congregate shelter models, and permanent supportive housing. Berwyn's local

homelessness prevention and service activities benefit from these broader regional resources. Cook County continued assessing the impacts of the Just Housing Amendment, and the city remains engaged with the Cook County Consortia to align with evolving Affirmatively Furthering Fair Housing (AFH) requirements. Rising home prices across the region also continued to affect affordability, and the City will maintain coordination with the County to monitor trends and support strategies that expand housing opportunities for all residents.

Berwyn's actions to reduce the number of poverty-level families include both CDBG-funded and non-CDBG efforts. The City employs a comprehensive approach focused on promoting self-reliance, creating new economic and housing opportunities, and ensuring affirmative participation in available programs. These actions include reducing housing and transportation cost burdens and providing direct assistance to households at risk of poverty or experiencing severe needs. Through these combined strategies, the City seeks to stabilize vulnerable households and improve long-term economic outcomes for low- and moderate-income residents.

The City will comply with the mandates of Section 3 of the Housing and Urban Development Act of 1968, as amended, in providing training and employment opportunities in connection with projects awarded under its CDBG contracts. In addition, the City encouraged new and expanding businesses to hire Berwyn residents for jobs created through TIF and other development incentives.

Berwyn also continued its partnerships with subrecipients and others to provide direct services, referrals, and mentoring to residents in poverty or on the brink of poverty. The City addressed the physical safety and improved health of residents threatened with isolation and exclusion, including those with disabilities, Veterans, seniors, persons experiencing homelessness or at risk of homelessness, and victims of domestic violence and HIV/AIDS. A major effort to reduce the impact of service cutbacks and rising living costs, especially for seniors, will support transportation, general home maintenance programs, police protection, and community facilities. While this may not reduce poverty for some, it will ensure that resources are used to their maximum benefit and may provide enough assistance to permanently improve their circumstances.

Actions taken to develop institutional structure. 91.220(k); 91.320(j)

The Community Development Department staff maintains the professional experience and expertise required to administer and account for the city's community development program. That experience includes working with subrecipients, residents, and service providers, as well as with HUD's IDIS and accounting systems.

- The City expanded interdepartmental utilization and leveraging of federal and local resources, primarily through the expansion of mental health services with CV funds.
- The City also expanded its technical assistance efforts with subrecipients to better understand CDBG requirements and expenditure documentation. This has enhanced the capacity of local

- agencies and enabled better resource leveraging.
- Berwyn continues to live-stream a broad range of committee meetings (e.g., City Council meetings, zoning meetings, etc.).
- The Community Development Department participates in Cook County Consortium meetings in partnership with HUD to coordinate with the County and fellow Entitlement members and expand coordination for work with common subrecipients.

Actions taken to enhance coordination between public and private housing and social service agencies. 91.220(k); 91.320(j)

During PY 2024, the City developed its 2025-2029 Consolidated Plan as a member of the Cook County HOME Consortium. The process included ongoing meetings among regional jurisdictions and outreach to social service agencies.

CDD personnel continue to coordinate services to help link senior citizens with other programs, and they continue to participate in the Alliance to End Homelessness in Suburban Cook County and the Cook County Continuum of Care.

The City makes efforts to include all members of the public in the planning and reporting process, including outreach to non-English speaking residents and persons with disabilities. Berwyn has analyzed its non-English speaking population and found that Spanish is the only language with a significant number of speakers. Accordingly, the City of Berwyn makes Spanish-speaking translators available at its meetings.

To accommodate persons with disabilities, the City holds all public hearings in locations accessible to persons with mobility impairments and will make reasonable accommodations to other persons upon request. It also began holding more virtual meetings during the program year.

Identify actions taken to overcome the effects of any impediments identified in the jurisdictions analysis of impediments to fair housing choice. 91.520(a)

Although still relatively affordable compared to many other jurisdictions, housing costs in Berwyn have continued to rise in recent years. As of November 2025, home prices in Berwyn increased slightly from the previous year, with a median sale price of approximately \$335,000. As a result, housing affordability and availability have become growing barriers to fair housing choice in the community. To address these challenges, the City is working closely with private lenders, the State of Illinois, and Cook County to identify and leverage resources to maintain access to Berwyn's housing stock for current residents and future homebuyers.

For renters, the FY 2025 Fair Market Rents (FMR) for Chicago-Joliet-Naperville, IL HUD Metro FMR Area Small Area FMRs Cook County, Illinois, for a studio was \$1,330; one-bedroom \$1,420; two-bedroom \$1,600; three-bedroom \$2,060, and four-bedroom \$2,410. Rents in the City of Berwyn were slightly

lower. The average rent for a studio apartment was \$975; one-bedroom \$1,200; two-bedroom \$1,680; three-bedroom \$2,300; and four-bedroom \$2,500. The increased rents for four-bedroom units are significant because Berwyn lacks larger units with four or more bedrooms. These larger units are in greater demand, which should drive their cost higher over the short run. At the same time, the lack of new housing development and rental opportunities, especially for seniors and young families, continues to put additional pressure on the existing housing inventory. The new small area FMRs, which guide Cook County's housing choice vouchers, are lower than these FMRs, raising the possibility that voucher-holders searching for housing in Berwyn will not be accommodated.

Berwyn continues to advance efforts to make its housing stock more energy-efficient and free of environmental hazards. Improving energy efficiency and mitigating risks such as lead-based paint remain essential to promoting healthy living conditions for residents—goals that could be further supported through additional funding. The City remains optimistic that ongoing comprehensive planning efforts and grant initiatives led by CMAP and the West Cook County Housing Collaborative will create new opportunities for transit-oriented, affordable housing development in Berwyn.

For individuals experiencing homelessness, gaps within the existing service delivery system continue to slow progress toward providing permanent supportive housing. Although supportive services do exist, the shortage of case workers and the need for a fully implemented, Continuum-wide approach limit the ability to serve chronically homeless individuals effectively. Additionally, the City is concerned about the number of low-income residents and children who are at imminent risk of needing shelter or becoming homeless, underscoring the importance of coordinated regional strategies and expanded resources.

The City's subrecipients will continue to support the city's homeless and non-homeless special needs populations. These agencies will continue to leverage and extend the limited funding available through the CDBG Program. The city will encourage coordination and leverage of scarce resources to fill service gaps and eliminate duplications of service.

The city's Community Relations Commission will continue to serve as the focal point for individuals experiencing or reporting bias. Counseling and intermediary services will be available from organizations such as the John Marshall Fair Housing Legal Support Center, the Heartland Alliance, the Sergeant Shriver Center, the Chicago Community Trust, and the Chicago Coalition for the Homeless.

CR-40 - Monitoring 91.220 and 91.230

Describe the standards and procedures used to monitor activities carried out in furtherance of the plan and used to ensure long-term compliance with requirements of the programs involved, including minority business outreach and the comprehensive planning requirements

The City implemented revised monitoring policies and procedures in PY2015, placing greater emphasis on ensuring that subrecipients remain compliant with CDBG and OMB regulations and that awarded funds are used to meet the objectives outlined in their applications. These strengthened policies continue to guide the City's monitoring practices, helping maintain accountability, transparency, and alignment with program goals.

The City advertises Invitations for Bid to expand outreach and promote contracting opportunities for Minority Business Enterprises (MBEs) and Women's Business Enterprises (WBEs). Contractors are also required to solicit participation from MBE and WBE subcontractors.

In PY 2024, the City held discussions with all approved subrecipients to review program expectations, reporting requirements, and key compliance issues, including income verification and contract obligations. Before issuing any payments, CDD staff conduct detailed reviews of all invoices to confirm that proper documentation is provided and that contractually required services have been completed.

In accordance with its "Monitoring Standards and Procedures" guide, the City also conducted in-person monitoring visits with four subrecipients to evaluate reimbursement submissions, the incomeverification process, and overall program performance.

Finally, each subrecipient is required to submit an annual report, which the CDD uses to determine whether planned objectives were achieved in a timely and cost-effective manner. These contracts and reports enable the city to meet HUD reporting requirements and to compare actual accomplishments against proposed performance outcomes.

Citizen Participation Plan 91.105(d); 91.115(d)

A draft of this report was made available for public review and comment from November 25 through December 9, 2025, and will hold a public hearing on the CAPER on December 5, 2025, at 10:00 a.m. @ 6700 W 26th Street, Berwyn, Illinois. The complete document is available for review at Berwyn City Hall, Berwyn Public Library, the Community Development Department, and on the city's website.

PY2024 represents the final year of the city's 2020–2024 Consolidated Plan. Over the past program years, the City implemented strategies to address priority needs identified in the plan, including housing rehabilitation, public infrastructure improvements, homelessness prevention, and public services targeting seniors, youth, and low- and moderate-income residents. Lessons learned during implementation—such as challenges in identifying income-qualified households for housing programs, the importance of coordinated regional partnerships, and emerging affordability pressures—have informed the development of the city's next planning cycle.

The City has developed a new 2025–2029 Consolidated Plan that reflects current community needs, local infrastructure priorities, and insights from prior program years. The updated plan places a strong emphasis on infrastructure improvements, including ADA accessibility upgrades, facility enhancements, and projects that support safe, sustainable public spaces. While the plan continues to recognize the importance of maintaining quality housing and addressing affordability challenges, its primary focus is on reducing barriers for vulnerable populations through improved accessibility, strengthening essential community services, and enhancing coordination with Cook County and regional partners to meet emerging needs.

By reviewing outcomes from the 2020–2024 plan and integrating lessons learned, the city is positioned to efficiently focus resources, strengthen program performance, and continue making measurable progress toward meeting the needs of its low- and moderate-income residents during the 2025–2029 Consolidated Plan period.

CDBG-CV

The community's needs and resources available to address the impact of the COVID-19 pandemic have continued to evolve since the city received CDBG-CV funding in 2020. Initially, the greatest need identified was to help families experiencing a sudden loss of income to remain in their homes. The City awarded a partner organization \$698,121 to provide short-term emergency rental, mortgage, and utility assistance to low-income households experiencing income loss due to COVID-19. The City also awarded another partner \$20,000 in operating support to cover additional shelter costs associated with the COVID-19 response. However, the City cancelled both programs due to inactivity and the availability of other resources to fund such programming.

The City reallocated funds and completed projects to improve ventilation and ADA accessibility of the Berwyn Recreation Center, which serves as a warming and cooling center. The project replaced the heating and air-conditioning system with high-efficiency units that improved ventilation, reducing the

transmission of future viruses. Funds were also used to enhance accessibility for people with disabilities at the center.

The City also reallocated CDBG-CV funds to assist the Berwyn Police Department in responding to increased incidents of domestic violence and the need for mental health services, mitigating the impact of the COVID-19 pandemic. Although the program has successfully served Berwyn residents, the recipient organization elected to continue operating the counseling services without CDBG funding due to the administrative and documentation requirements.

The City is investigating other potential uses of the CDBG-CV funds to prevent, prepare for, and respond to the impacts of the coronavirus before they expire in 2026.

The City certifies that the city:

- provided certifications of consistency in a fair and impartial manner;
- did not hinder Con Plan implementation by action or willful inaction;
- pursued all resources described in the Consolidated Plan; and
- used all CDBG funds for meeting a national objective. The city spent 100% of its CDBG program funds (not including administrative and loan payments) on activities that met a low- and moderate-income national objective.

In PY2024, the Berwyn Police Counselors Program provided critical support to 40 residents experiencing domestic battery. Counselors engaged affected individuals through multiple outreach phone calls, offering crisis intervention, safety planning, and ongoing emotional support. Although this remains a highly valuable program for the community, the Police Department has elected to continue operating it without CDBG funding due to the administrative and documentation requirements associated with the program.
